

**NAPLES RESERVE COMMUNITY DEVELOPMENT DISTRICT
NOTICE OF TELEPHONIC PUBLIC MEETING HELD DURING PUBLIC HEALTH EMERGENCY DUE TO
COVID-19**

Notice is hereby given that the Board of Supervisors (“Board”) of Naples Reserve Community Development District (“District”) will hold its previously noticed regular meeting of the Board on May 5, 2020 at 11:00 a.m. by means of communications media technology described herein pursuant to Executive Orders 20-52 and 20-69 issued by Governor DeSantis on March 9, 2020, and March 20, 2020, respectively (collectively, the “Executive Orders”), and pursuant to Section 120.54(5)(b)2., Florida Statutes. Consistent with the Executive Orders and except as otherwise provided for herein, there will not be any Supervisors or staff physically present at a specific meeting location for this meeting. The meeting is being held for the necessary public purpose of considering a proposed budget for Fiscal Year 2020-2021, adopting resolutions related to the District’s upcoming general election and internal controls policy, considering acceptance of the Fiscal Year 2019 audited financial report and any other business that may properly come before it, which are necessary for the proper operation of the District.

*While it is necessary to hold the above referenced meeting of the District’s Supervisors utilizing communications media technology due to the current COVID-19 public health emergency, the District fully encourages public participation in a safe and efficient manner. In the event the Executive Orders are rescinded or expire, the District may cancel the scheduled virtual/telephonic meeting or it may revert to having the meeting at the date, time and physical location previously noticed.
